# 1 Purpose and Scope of Document:

This Privacy Policy describes our policy and procedures on the collection, use and disclosure of your information when you use the Exponant website and tells you about your privacy rights and how the law protects you.

#### 2 Audience:

All website users.

#### 3 Definitions

For the purposes of our Privacy Policy:

- Company referred to as either "the Company", "We", "Us" or "Our" in this agreement refers to Exponant (Pty) Ltd, Building 32, Oxford Office Park, 3 Bauhinia Drive, Highveld, Centurion, Gauteng 0157 South Africa.
- Cookies are small files that are placed on your computer, mobile device or any other device
  by a website, containing the details of your browsing history on that website.
- Country refers to South Africa.
- Usage data refers to data collected automatically from the service infrastructure itself like for example duration of a page visit.
- Personal data- Your name and IP address, email address and company name which appear
  in the comment. This can only be seen by the administrators of this website. The public can
  only see your name and the comment.
- Website refers to Exponant and can be accessed from <a href="www.Exponant.com">www.Exponant.com</a>;
- You means the individual using the website, or the company, or other legal entity accessing or using the website as applicable.

## 4 Collecting and using your personal data

#### 4.1 Types of data collected

Exponant uses Google Analytics to collect usage data on the website. Personally identifiable data is not collected by Google Analytics which only accumulates usage information. Exponant uses this to track our website as a marketing instrument.

Usage data is collected automatically when you visit the website in includes information such as your device's Internet Protocol (e.g IP address), browser type, browser version, the pages of the website that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the website through a mobile device, Google Analytics collects certain information automatically including but not limited to, the type of mobile device, your mobile device's unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile internet browser, other unique device identifiers and diagnostic data.

If you comment on the site, in the blogs, Exponant can see your name, surname and IP address. We will only use this data for the purpose it was sent, whether that is to add an insight or request a service. By interacting on the site, you are giving Exponant permission to use this information for the purpose it was intended.

## 4.2 Other legal requirements

Exponant may disclose your personal data in the good faith and belief that such action is necessary to:

- · Comply with legal action;
- Protect the rights or property of the company;
- Prevent or investigate possible wrongdoing in connection with the website;
- · Protect the personal safety of users of the website or the public; and
- Protect against legal liability.

# 5 Security of your personal data

The security of your personal data is important to us, but remember that no method of transformation over the internet or electronic data storage is 100% secure. While we use commercially acceptable means to protect your personal data, we cannot guarantee its absolute security.

# 6 Tracking cookies

Google Analytics uses "persistent cookies". These cookies are used to identify unique visitors. They expire two years from the date they were last refreshed. Every time a new hit is sent to Google Analytics, the cookies are refreshed.

A persistent cookie means it remains on the user's browser until it expires or the user clears the cache. We use this information for data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns, to improve our service offerings and security.

# 7 Transferring Data

We do not transfer your data other than in internal web usage report wherein you are not identified. We
